CONTRACT AGREEMENT

This Agreement made the _____ day of _____ 2017

between

1. The private company with limited liability **Schiphol Nederland B.V.**, with its registered office at Evert van de Beekstraat 202 (1118 CP), Schiphol, The Netherlands, listed in the commercial register of the Dutch Chamber of Commerce and Industry under number 34166584, duly represented by its managing director **Royal Schiphol Group N.V.**, duly represented by Mrs B. I. Otto, Chief Operations Officer and Mrs. J. T. M. van der Meijs, Chief Financial Officer;
(hereinafter referred to as "the Client"),

and

(e) the Letter of Proposal

(f) the Consultant's Proposal.

3. In consideration of the payments to be made by the Client to the Consultant under the Agreement, the Consultant hereby agrees with the Client to perform the Services in conformity with the provisions of the Agreement.
4. The Client hereby agrees to pay the Consultant, in consideration of the performance of the Services, such amounts as may become payable under the provisions of the Agreement at the times and in the manner prescribed by the Agreement.
5. The Consultant acknowledges that it is in possession of the General Conditions that are applicable to the Agreement pursuant to Clause 2(c) above and that form part of the FIDIC White Book: the 'Client/Consultant Model Services Agreement', Fourth Edition 2006, published by the *Fédération Internationale des Ingénieurs-Conseils (FIDIC)* with ISBN 2-88432-048-2 and available through www.fidic.org.
