Via a Market consultation de N.V. Nederlandse Gasunie would like to get a better impression of the available possibilities in the market for plastic pipelines. The transition to a carbon free energy society means other types of energy carriers and other gaseous mediums that have to be transported in large volumes through pipelines. At this moment all the Gasunie pipelines used for transporting natural gas are steel pipelines. Gasunie is investigating the use of other materials for gas transport. Therefore Gasunie wants to know more about in the possible use of plastic materials for pipelines. We think that plastic pipes could be an alternative material with interesting benefits and a lower Total Cost of Ownership. But at this moment we do not have enough useful information to analyse the savings potential of plastic pipe.
