The aim of the Porthos project is to transport CO2. This CO2 is in gas phase in the onshore pipeline through the Port of Rotterdam. In the compressor station the CO2 is compressed in 4 stages to super critical phase (T $\pm$ 370K; P $\pm$ 130 bar) in which it is transported to a depleted gasfield under the sea bed.

For the project valves are needed, not only in the gaseous phase before the CS but also for the supercritical and liquid phase afterwards.
