Please explain in a clear and comprehensive manner why the award of the contract without prior publication in the Official Journal of the European Union is lawful, by stating the relevant facts and, as appropriate, the conclusions of law in accordance with the directive: This concerns the purchase of an AVANCE NEO 300 MHz WB Spectrometer Console to be linked to an existing AVANCE III 300MHz spectrometer. The console must be compatible with our existing Bruker magnet. The specifications of the new console must restore and upgrade the existing of the current, 12-yr old, Bruker console with respect to basic functioning of the console, micro-imaging and MAS NMR capability. The console also needs to work with existing Bruker probeheads (spectroscopy, diffusion, solid state) and VT accessories. This Console can only be delivered by Bruker and cannot be purchased anywhere else.
