Maastricht University (UM) is known in the Netherlands and abroad for its unique education system: problem-based learning. UM also distinguishes itself by its strong international orientation. More information on UM can be found on the internetsite www.maastrichtuniversity.nl.

The ETpathfinder, currently under construction at UM, will consist of two Fabry-Perot Michelson Interferometers (FPMI). The mirrors in these interferometers are made of crystalline silicon and in one FPMI these need to be cooled to 20 K (or lower). In the ETpathfinder baseline design this low temperature is to be established by sorption-based cryocoolers. The ETpathfinder cooler will have two or three cold stages of which the first stage will be operated with neon as the working fluid. These sorption-based cryocoolers need to be developed.
