1. Introduction

The Tender Document at hand contains information regarding this invitation to tender conducted in accordance with the European open procedure for executing the geophysical survey at the IJmuiden Ver Wind Farm Sites V and VI (IJ56).

You are hereby invited to submit a Tender based on this Tender Document.

1.1 Tendering Authority and IUC-EZK

This tendering process is being conducted by the Netherlands Enterprise Agency (In Dutch: Rijksdienst voor Ondernemend Nederland – RVO).

The Procurement Office or Inkoop Uitvoering Centrum EZK (IUC EZK) will act as process manager during this tendering process.

The Netherlands Enterprise Agency encourages entrepreneurs in sustainable, agrarian, innovative and international business. It helps with grants, finding business partners, know-how and compliance with laws and regulations.

The Netherlands Enterprise Agency is part of the Ministry of Economic Affairs and Climate Policy and focuses on providing services to entrepreneurs. It aims to make it easier to do business using smart organisation and digital communication. The Agency works in The Netherlands and abroad and co-operates with governments, knowledge centres, international organisations and countless other partners.

1.2 Reason for this invitation to tender

The Dutch Government has developed a systematic framework under which offshore wind farm zones are designated. Any location outside these wind farm zones is not eligible to receive a permit. Within the designated wind farm zones the government designates the specific sites where wind farms can be constructed, using a so-called Wind Farm Site Decision ('Kavelbesluit'). This contains conditions for building and operating a wind farm on a specific site. The Dutch Government provides the relevant site data and Dutch transmission system operator TenneT is responsible for the grid connection.

Winners of the site development tenders will be granted a permit to build a wind farm according to the Offshore Wind Energy Act (Wet Windenergie op zee) and will be offered a grid connection to the main land. The Ministry of Economic Affairs and Climate Policy provides site data, which can be used for the preparation of bids for these tenders.

In light of the success of the road map towards 4,500 MW (2015-2019), the Ministry has published a new roadmap to 2030. This calls for the deployment of additional 7,000 MW of offshore wind by 2030. In total, the additional MW's planned would bring the Netherlands' total offshore wind capacity to 11,500 MW. RVO and TenneT have already started preparations for the newest Wind Farm Zone to be developed under the 2030 roadmap, IJmuiden Ver. In the roadmap 2030 four sites are envisaged with a total of 4,000MW within this Wind Farm Zone. Recently the government decided to increase the total capacity of the IJmuiden Ver Wind Farm Zone with two additional sites, bringing the total capacity to 6,000MW. The 2 additional sites are named IJmuiden Ver Wind Farm Sites V-VI (IJ56) and are located in the northern part of the IJmuiden Ver Wind Farm Zone.

Additional information on the legislative framework and the designated offshore Wind Farm Zones in the Netherlands can be found in Annex 6 – VI, Starting points and Assumptions.

The Netherlands Enterprise Agency has been requested to prepare and collect site data required for commercial developers to prepare a competitive bid. As part of the future Permit Call for Tender document(s), the participants will receive information packages in which detailed information on the offshore site is included. Detailed information on the soil conditions at the site will be part of this information package.

The objective of this tender is to conclude a Contract with one Tenderer who is able to carry out the geophysical investigations required to improve the bathymetrical, morphological, archaeological and geological understanding and identification of objects at IJ56. This information must be suitable as input for scoping and preparing geotechnical site investigations and for integration into a Ground Model of sufficient quality to progress the design and installation requirements for offshore wind farms, including, but not limited to foundations and infield cables. The information from the investigation will be made available to all potential bidders for offshore wind farms in IJ56.

The Contracting Authority intends to conclude a Contract with the Tenderer who has submitted the most economically advantageous tender (based on the best quality/price ratio). The future CONTRACTOR, as well as the services/products to be performed/delivered by the CONTRACTOR, must fulfil the terms and conditions to be set by the Contracting Authority and specified in this Tender Document.

2. Description of assignment

2.1 Description and objective of the assignment

This assignment includes executing a geophysical investigation consisting of;

- 2D survey of the whole IJmuiden Ver Wind Farm Sites V and VI (IJ56)
- 3D survey within specific sections of IJmuiden Ver Wind Farm Sites V and VI (IJ56)
- Additional 2D survey lines* / Tie-lines within the IJmuiden Ver Wind Farm Zone or towards new potential WFZ searching areas for offshore wind development.
- Seabed sampling by means of Vibrocore, Box core/grab sampling
- Water sampling (For eDNA) for ecological assessments

More detailed information concerning the specifications of this assignment can be found in Annex 6 Contract Documents, including all sections:

*the Contracting Authority requests the Tenderer to provide a price and duration to conduct 2D survey lines. Price and duration shall be based on 300 km of 2D survey lines (best estimate at the time of the tender). The additional 2D survey lines are anticipated to be located between the investigation area (IJ56) and surrounding locations (e.g. tie lines towards potential areas for the development of offshore wind, tie lines to the sites of IJmuiden Ver I-IV or survey lines within an area for a first identification of a site).

The exact amount and location of the additional 2D survey lines will be determined by the Contracting Authority prior the mobilisation of the vessel.

To be able to price the additional survey lines the Contracting Authority estimates the average length of those survey lines at 25 km without transits, just line turns. The specifications for 2D survey are detailed in Annex 6, section IV, Scope of Work.

2.2 Lots

This tender is not divided into lots, because the surveys to be executed are linked to each other and form a consistent package. Therefore it is essential that the survey will be executed by one contractor. Multiple contractors would lead to a more expensive solution of lower quality.

2.3 Contract Period

The anticipated commencement date of the Contract is February 15, 2022. The end date is set at April 1, 2023.

CONTRACTOR will have the flexibility to select the most convenient schedule within this contract period to perform the WORK. The WORK shall be conducted in a single campaign and shall not be interrupted to perform WORK outside of this contract without written approval from Contracting Authority.

2.4 Scope of the assignment

The Tendering Authority has estimated the total contract value at a maximum of EUR 7.000.000,-- (including VAT).

The estimated value is an indication from which no rights can be derived. This Tender Document was created using up-to-date knowledge and insights valid at the time of its formulation.

It is possible that the services specified in the contract may change in the event of political, budgetary, administrative or organisational developments within the Dutch government and the Contracting Authority's expansion or contraction resulting from this, or changes to the Contracting Authority's position within the government or to the targets that must be met. In the event such circumstances occur, the Contracting Authority will consult with the Contractor.

3. Requirements to this assignment

This section includes the requirements set by the Tendering Authority concerning the requested services and the prices and rates.

By submitting a Tender, you as Tenderer, explicitly consent to all requirements and conditions specified in this Tender document and declare that you will continue to comply with these throughout the entirety of the contract period. Furthermore, you confirm that you will comply with all of the specified prices and rates, including any agreed indexation. Failure to comply with one or more requirements will result in your Tender being disqualified from the assessment process and therefore excluded from the tendering process.

3.1 Requirements relating to execution of the WORK

- Tenderer is willing and able to execute the WORK regarding the geophysical site investigations that need to be carried out under the Contract. Tenderer is willing and able to execute the WORK in compliance with the Scope of Work as described in the documents as presented in Annex 6.
- The WORK related to the investigations to be conducted will be executed in accordance with (the latest version of) the Project documentation produced by CONTRACTOR and subject to approval by the Contracting Authority, unless the Contracting Authority has given permission in writing to do otherwise.

3.2 Requirements relating to vessel(s) and equipment

Materials and equipment or parts thereof provided by the Tenderer must be of good quality and workmanship, in a good state of repair, with up-to-date calibrations where required by recognised standards and/or good working practice, and fit for the intended purpose.

Requirements survey vessel(s):

- Vessel(s) should have a minimum length overall of 40 metres and a beam of 8 metres and must be capable of undertaking the WORK as specified in the Scope of Work. It is up to the tenderer to propose to engage one or two vessels; It is not allowed to engage more than two vessels.
- Vessel(s) must be capable of continuous operation during 7 days a week, 24 hours a day.
- Vessel(s) must have adequate capacity and facilities for:
 - accommodating (berths and work space) for both marine and survey crews including two Client Offshore Representatives for working in two 12 hours shifts per day;
 - onboard QC and all required processing for Quality Assurance;
 - storage and bunkering capacity for spares, consumables, fuel etc.;
 - comply, as a minimum, to the code of practice for workboats as specified in IMCA M 189 Rev. 2;
- CONTRACTOR must submit prior to mobilization an independent inspection report that includes 'Checklist Based on Approved Code of Practice for Workboats' as specified in 'IMCA M 189 Issue 4.1 (April 2020), IMCA S 004 Issue 4.1 (April 2020)'. This inspection report should not be older than six months and all items in the checklist are answered with 'Yes' or 'N/A'.

Requirements equipment:

- Equipment for the performance and storage of 3D UHRS, MBES, SSS, magnetometer, acoustic, 2D UHRS, Vibrocoring (6m), water sampling, ecological and seabed sampling surveys as described in the Scope of Work, including an appropriate spares inventory, should be deployed ready for use on the survey vessel.
- Contracting Authority shall ensure environmental exemption (underwater noise) for use of the required equipment inside IJ56 for the duration of the WORK. Tenderer shall provide the required documentation to Contracting Authority as part of the tender. The following documentation shall be provided:

- 1) Equipment details of any sub bottom profiler including conservative estimate of the Sound exposure level single strike (SELss) with the operational frequency of the sub bottom profilers for the application of environmental exemption (underwater noise).
- 2) Method statement describing the soft start procedure containing:
 - a. Use of Acoustic Deterrent Device (ADD) for porpoises, each survey day, and when sub bottom profilers are not used, for 1,5 hours.
 - b. Minimum use of the ADD for 5 minutes.
 - c. Soft start procedure of the sub bottom equipment with description of duration and power settings of the equipment to allow porpoise mammals to leave site based on a transit speed of 7,5 km/h .

Tenderer is to provide a Letter of Confirmation (Annex 5) by the 5th of January 2022, in which it is confirmed that the proposed vessels and equipment are available.

3.3 Compliance requirements

The vessel(s) and equipment used for the purpose of executing the WORK must comply with the specifications that are included in the Tender of the Tenderer.

Variations in vessel(s), tools and equipment with respect to those proposed in the Tender after commencing the Contract is subject to approval by Contracting Authority. Any variation must, as a minimum, provide the same or better quality and/or performance than the vessel(s), tools and equipment included in the Offer. Judgement as to the suitability of the vessel(s), tools and equipment proposed shall be at the discretion of Contracting Authority. Variations must therefore fulfil the requirements listed in section 3.2 and assessment of the variation according to the relevant preferences in section 5.2.3 must be compliant with the awarded score of the original Tender. For performance of an alternative vessel, Contracting Authority will assess if the size, workability, sailing characteristics and possibilities to deploy equipment are equal or better.

3.4 Requirements relating to personnel

All personnel involved in the execution of the WORK (data acquisition, data processing, interpretation and reporting) must :

- have contributed to at least one relevant offshore geophysical survey) using the equipment (including software) proposed here. If equipment or software is new, expertise with an equivalent together with appropriate training prior to survey is required, and if this is mission critical then details and proof of training should be required.
- have been trained for working in the offshore environment as demonstrated by their CV's.
- have (medical) certificates valid for the duration of the contract, to perform work in the Dutch North Sea, including as a minimum BOSIET (Basic Offshore Safety Induction and Emergency Training) or equivalent
- have a working permit (the right to work in the investigation area of IJ56) valid for the duration of the contract

Tenderer is to provide a Letter of Confirmation (Annex 5) by the 5th of January 2022, in which it is confirmed that the proposed personnel are available.

Variations in personnel to those proposed in the Tender *after* commencing the Contract is subject to approval by Contracting Authority. Any variation must as a minimum provide the same or better qualifications and experience as proposed in the Tender.

3.5 Requirements relating to the prices/rates

3.5.1 The Tenderer will provide an overview of the prices and rates applicable to this assignment by filling in the Annex 4 (Cycle times and Prices/Rates).

By completing the Annex 4, Tenderer gives an overview of all maximum prices and rates for executing the work under the Contract. Bandwidths will not be accepted.

- The offered prices and rates are excluding VAT.
 - The offered (maximum) prices and rates comply with the conditions as laid down in the provisions of the Contract, as per Annex 4.
 - Prices higher than EUR 7,000,000 or lower than EUR 4,500,00 will be set aside by the Contracting Authority and will not qualify for award of the Contract.
- 3.5.2 The price/rates must be all inclusive. In any event, they must include all of the following: wage costs, overheads (e.g. accommodation and wage costs for support staff), costs relating to the use of equipment and machinery during the assignment, insurance costs, any applicable costs for e-invoicing, and local travel and accommodation expenses.
- 3.5.3 The Tenderer will not submit any zero or negative prices/rates.

3.6 Requirements relating to cycle times

By completing the Annex 4 (Cycle times and Prices/rates) of this Tender Document Tenderer provides a specification of maximum cycle times (terms) that apply to relevant parts of executing the WORK. Offers with end date later than 4 January, 2023 (item 71 in Annex 4) will be set aside by the Contracting Authority and will not qualify for award of the Contract.

3.7 Tax-related requirements

- 3.7.1 The Tenderer indemnifies the Contracting Authority against any claims from the Dutch Tax and Customs Administration (Belastingdienst) or other tax authorities.
- 3.7.2 The Tenderer will quote the prices according to the following structure:
- the amount excluding Dutch VAT and any VAT due outside the EU;
 - the amount of Dutch VAT due (if applicable) and the amount of any VAT due outside the EU, and;
 - the amount including Dutch VAT (if applicable) and any VAT due outside the EU.
- 3.7.3 If the Tenderer indicates that no VAT is applicable, then he agrees to provide documentary proof of the grounds for this to the Contracting Authority within fifteen calendar days of the request to do so.
- 3.7.4 You are liable for any extra costs for Dutch and/or foreign VAT due if you incorrectly charge no VAT or an incorrect amount of VAT to the Contracting Authority. If applicable, you are liable for accurate payment of VAT in the Netherlands and outside the EU, with the exception of the case stipulated in the following sentence. If the Contracting Authority procures a service from a foreign business and Dutch tax law considers the work to have been performed in the Netherlands, then the Contracting Authority is liable for the payment of VAT to the Dutch Tax and Customs Administration for this/these service(s) performed in the Netherlands.
- 3.7.5 You guarantee that the amounts specified in the quotation are inclusive of all taxes and levies (including amounts considered equivalent to taxes or levies), regardless of their description and wherever in the world they may have been levied.
- 3.7.6 You indemnify the Contracting Authority against any claims from any tax authority for any taxes, levies or contributions considered equivalent to taxes or levies, originating from either the Netherlands or outside the Netherlands.
- 3.7.7 If you believe that your work is being taxed simultaneously (in part or in full) in both the Netherlands and a foreign country (outside the EU), then you agree to provide evidence from the foreign tax authorities in question that prove VAT has been levied on one of the services/amounts substantiated by you in the quotation. You will provide this statement in English. If the statement from the foreign tax authorities is not in English, then you agree to provide a sworn translation of this statement, the costs of which will be borne by you.

3.9 Environmental requirements

The Tenderer must possess all environmental permits required in order to fulfil this assignment, including permits and or exemptions for operation of the required equipment within the Investigation Area of IJ56.

To perform survey activities with seismic equipment an environmental exemption is required.

Contractor shall assist with the provision of all required documentation of the proposed equipment as soon as reasonably possible upon request of Contracting Authority.

During the execution of survey activities CONTRACTOR shall follow the guidelines as included in the exemption letter including, a soft start of the equipment and provision and deployment of an acoustic deterrent device specific for porpoise mammals.

4. Requirements concerning the Tenderer

4.1 Introduction

In this section, you can find the requirements set by the Tendering Authority to determine whether particular Tenderers are suitable to be awarded the Contract. For this purpose, Exclusion Grounds and Suitability Requirements have been set.

The 'European Single Procurement Document' is a PDF file that has been partially filled in for you. You must fill in the rest of the form, print it, legally sign it, scan it and submit it together with your Tender via TenderNed (see paragraph 7.3.15).

4.2 Exclusion Grounds

The following Exclusion Grounds are specified in the annex 'European Single Procurement Document':

- all Exclusion Grounds specified in Part III A and B;
- the Exclusion Grounds in Part III C of the 'European Single Procurement Document' that have been selected by the Tendering Authority by means of the tick boxes.

See Section 7.3.17 for information on how to submit a Tender in collaboration with other organisations. This section specifies who must provide a completed and signed European Single Procurement Document during the process of submitting a Tender.

The evidence relating to the Exclusion Grounds does not have to be submitted together with the Tender: it is only required once the Tendering Authority requests it.

Please note: The process of applying for a GVA (certificate of conduct) can take several weeks.

By signing the annex 'European Single Procurement Document' (which uses the term 'Selection Criteria' to refer to the Suitability Requirements), the Tenderer declares that he complies with the Suitability Requirements as specified in this subsection of the Tender document. These Suitability Requirements are further specified in the subsequent paragraphs in this section.

In order to avoid errors on this subject Tenderers are expressly invited to ask questions for clarification (see § 7.3.3).

4.3.1 Financial and economic standing

 - Sampling of Seabed Sediments (ground truthing/environmental);
 - Sampling of Sub-Seabed Sediments (Vibrocore sampling).
2. Execution of an investigation in which expert knowledge of the upper 100 meter of the North Sea basin (seabed morphology, geology) was needed;
3. Provision of vessel and equipment suitable for the execution of 3D UHRS site investigations.

 - Performance of a periodic and independent audit concerning compliance with environmental protection agreements.
 - Availability of a report concerning compliance with environmental protection agreements.

For the award criteria § 5.2.1 (Project Documentation), § 5.2.2 (Qualifications of personnel) and § 5.2.3 (Vessels, equipment and team) a minimum average of 60% (rounded up) of the maximum number of points should be obtained. Tenders that do not meet this requirement will be set aside by the Tendering authority and will not qualify for award of the Contract.

It is advised not to include other documents in the Tender in order to prevent that relevant information is not taken into account in the assessment. - CV's of all proposed key personnel. Not providing these CV's will lead to a 0% score for these persons.
- The CV's should contain a description on the roles performed during the work experience. It is important to state in the CV what kind of sensors, data and software were involved in the projects performed by the proposed key personnel
- Qualifications and experience of the total pool of key personnel that could be designated to the project team over the whole duration of the WORK. **Please note that all key personnel that CONTRACTOR wishes to deploy for the execution of the WORK (onshore & offshore) shall be included in this pool. This means that both designated project team members and possible replacements / backups shall be added to this pool.**

5.2.5 Award criteria relating to sustainable campaign execution

Tenderer is requested to describe the sustainability of the survey campaign in a separate chapter in the Project HSE Management Plan.

6. Assessment of the Tender

6.1 Assessment of the Tender's completeness and legal validity

The Tender will be assessed according to the following procedure. The Tendering Authority will check whether:

1. all required documents have been provided (see the checklist in the subsection 'Structure and content of the Tender' in Section 7);
2. the information is correct and complete, and no adjustments have been made to the documents provided by the Tendering Authority;
3. no provisos have been made by the Tenderer (e.g. specifying that the Tenderer's own terms and conditions apply);
4. the 'European Single Procurement Document' has been completed in full and has been legally signed (please refer to 7.3.16 en 7.3.17.).

In the event that the aforementioned requirements have not been complied with, the Tender will be excluded from assessment and further participation in the tendering process, unless rectification is permitted within the boundaries of public procurement legislation.

6.2 Assessment of requirements relating to the assignment

Subsequently, the Tender's compliance with the requirements to the assignment (see Section 3) will be assessed. Any Tenders that do not comply, will be excluded from further participation in the tendering process.

6.3 Assessment of award criteria relating to the assignment

Subsequently, all Tenders not excluded from the tendering process, will be assessed according to the award criteria stipulated in Section 5.

6.4 Determination of definitive total score

The Contract will be awarded according to the principle of the Most Economically Advantageous Tender. The Most Economically Advantageous Tender is the Tender that achieves the highest definitive total score based on the best price-quality ratio.

The Tenderer's definitive total score will be rounded to one decimal place. No scores will be rounded off until the moment that this definitive total score is determined. If two or more Tenderers have an equal definitive total score that would result in the Tendering Authority having to award the Contract to more parties than is desired, then the Tendering Authority will award the Contract to the Tenderer with the highest final score for the criterion relating to price/rates (see section 5.3). In the event that the highest scoring Tenderers also achieve an equal score for this criterion, then determination of the Tenderer to which the Contract will be awarded will be made by drawing lots.

6.5 Assessment of evidence

At the moment that the Tenderer legally signs the 'European Single Procurement Document' and submits the Tender, the Tenderer is not (yet) required to provide any evidence, unless expressly asked to do so in this Tender document.

By signing the 'European Single Procurement Document' and submitting his Tender, the Tenderer agrees that at a later date, the Tendering Authority is entitled to request that the winning Tenderer provides the required evidence.

Upon awarding the Contract, the Tendering Authority will only request evidence from the winning Tenderer. The Tendering Authority is entitled to request this evidence at an earlier stage and from all Tenderers if it believes such a course of action is necessary to facilitate the progress of the tendering process.

The evidence must demonstrate that the Tenderer indeed complies with the content of both the 'European Single Procurement Document' and the Tender. Following the Tendering Authority's request to provide the evidence, the Tenderer has 20 (twenty) calendar days to hand over the required evidence. If the Tendering Authority does not agree with the content and/or validity of one or more of the pieces of evidence provided by the winning Tenderer, then this could result in the winning Tenderer being excluded from further participation in the process. In such cases, the Tendering Authority will inform every Tenderer of this situation. The Tendering Authority will then determine the next Most Economically Advantageous Tender.

In the event a winning Tenderer does not qualify for the definitive award of the Contract, then all Tenderers will be notified of this and the consequences thereof concerning the award of the contract.

7. Submission procedure for Tenders

7.1 Statement of agreement

By submitting a Tender, including the 'European Single Procurement Document', the Tenderer explicitly consents to all requirements and conditions stipulated in this Tender document and the Memorandum of Information and declares that he will continue to comply therewith throughout the entirety of the contract period. Furthermore, the Tenderer confirms that he will comply with all of the specified prices and rates, including any agreed indexation. Failing to comply with one or more requirements will result in his Tender being disqualified from the assessment process and therefore excluded from the tendering process.

7.2 Schedule

See schedule in Subsection 1.3.

7.3 General procedure

This tendering process will be carried out in compliance with the Public Procurement Act. In this case, the 'open procedure' was selected. An announcement thereof was published on www.tenderned.nl and on Tender European Daily (TED).

In the event that a Tender is not submitted in accordance with the provisions and regulations stipulated in this section, the Tendering Authority can set aside the Tender and exclude the Tenderer from further participation in this tender procedure.

7.3.1 Communication

All communication relating to this tender procedure will be conducted via TenderNed (www.tenderned.nl), unless otherwise specified.

Answers from the Tendering Authority

The Memoranda of Information are an integral part of this Tender document. The Tendering Authority assumes that all sections for which no questions have been asked have been clearly and fully understood.

7.3.4 Validity period and submission of Tender

The Tender must be valid for at least the four months after the deadline for submitting the tenders. In the event that an application for a preliminary injunction is filed with the competent court in The Hague against the award decision, then the Tenderers must in any event ensure that their Tenders are valid until four weeks subsequent to the initial decision by the court.

7.3.5 Variants on Tender

Upon submitting a Tender in accordance with the Tender document, the Tenderer is not permitted to submit a variant of this Tender.

7.3.6 Costs of submitting a Tender

The Tendering Authority will not reimburse any Tenderers for any costs resulting from the drafting and submitting of a Tender, including any further information requested of the Tenderer.

7.3.7 Termination of tendering process

Until the moment that the Contract is signed, the Tendering Authority reserves the right to partially, fully, temporarily or permanently terminate the tendering process. In such cases, Tenderers will not be entitled to receive compensation for any costs incurred by them in connection with this Tender, unless the Contracting Authority is of the opinion that a (small) contribution to the tender costs is appropriate in view of the circumstances.

7.3.8 Order of precedence of documents

In the event of inconsistencies between the Tender document and the Memorandum of Information, the Memorandum of Information takes precedence.

In the event that there are multiple Memoranda of Information, then the provisions in the most recent Memorandum of Information takes precedence in the event of inconsistencies between the different Memoranda.

7.3.9 Information about the Tenderer's obligations

The Tenderer must take into account his obligations relating to environmental, social and employment law in compliance with article 2.81 paragraph 2 of the Public Procurement Act.

7.3.11 Inconsistencies and objections

If the Tenderer is of the opinion that the documents contain inconsistencies, errors or matters that are unclear or if the Tenderer has any objections, then the Tenderer must report this to the contact person in writing, including substantiation.

7.3.12 Complaints procedure

7.3.16 Legally binding signature

A legally binding signature means that a document has been signed by a duly authorized representative.

If it is recorded in the professional or company register that two or more persons only have joint powers of representation, then the documents requiring a legally binding signature must be signed by those two or more persons. If any restrictions are in place regarding the authorization to represent the organization, then these must be taken into account.

Where a legally binding signature is required, the Contracting Authority accepts either an original handwritten signature, or the qualified electronic signature within the meaning of article 3: 15a of the Civil Code (or EU Regulation no. 910/2014, article 3, part 12).

Please note: it is not possible to sign the European Single Procurement Document with a qualified electronic signature immediately. You can provide the ESPD with a handwritten signature or you must make a digital PDF printout of the PDF form, after which the qualified electronic signature can be placed on this digital PDF printout.

The lack of a legally binding signature in principle will lead to exclusion from the tendering procedure. In that case, however, you will be given one single opportunity to correct it within 48 hours.

7.3.17 Submission of a Tender in collaboration with other organisations

If you cannot carry out the assignment independently, you can set up a collaboration with other organisations.

There are two ways in which you can submit a Tender in collaboration:

- 1) As a consortium in which each member of the consortium is jointly and severally liable for the fulfilment of the obligations arising from the Tender as well as the fulfilment of the Contract.

If a Tender is submitted by a principal contractor that does not rely upon the capacity of any subcontractors, then only the principal contractor is required to complete and legally sign Part II D of the 'European Single Procurement Document'.

If the principal contractor does rely on the capacity of subcontractors in order to demonstrate compliance with the applicable Suitability Requirements, then the subcontractor(s) in question must also complete and legally sign Part II C of the 'European Single Procurement Document'.

The principal contractor is fully liable for the fulfilment of the obligations arising from the Tender as well as the fulfilment of the contract (if awarded). In addition, the principal contractor is liable for the fulfilment of the obligations for which he has hired the subcontractor(s).

All completed and legally signed 'European Single Procurement Document' forms must be added to the Tender.

7.3.18 Single Tender

All natural persons, legal entities and organisations may only submit a single Tender (either individually or in combination with other natural persons, legal entities and/or organisations). Tenderers who are mutually connected via a relationship of dependence (group link) are permitted to participate separately in this tendering procedure. However, this is on the express condition that they participate as competitors in this tendering process. For this purpose, they must demonstrate that their mutual relationship has not influenced their behaviour within the scope of this tendering procedure nor has it restricted fair competition.

By submitting a Tender, the Tenderer in question agrees to this condition.

7.3.19 Violation of the fundamental principles of procurement law and restriction of fair competition

Any Tenderer whose actions violate a fundamental principle of procurement law (such as the equality principle), the result of which restricts or could restrict fair competition, will be excluded from this tendering procedure. This is also the case if the violation or the restriction of fair competition only comes to light after the announcement of the award of the Contract to all Tenderers. Prior to making the decision to exclude the Tenderer in question, the Tendering Authority will notify the Tenderer of this intention, at which point the Tenderer will be given the opportunity to demonstrate to the Tendering Authority that no violation of a fundamental principle of procurement law or restriction of fair competition has taken place.

By submitting this Tender, the Tenderer declares his awareness that actions contravening any fundamental principle of procurement law can result in the aforementioned consequences. The Tendering Authority can use all resources available to him in order to identify any violation of the fundamental principles of procurement law or the restriction of fair competition. A judicial decision will not be a necessary requirement in such cases.

7.3.20 Communication and language

During the tendering process, communication with the Tendering Authority must be conducted in English.

The Tender must be submitted in English.

Additional documents (such as informational materials etc.) can also be provided in English.

During the fulfilment of the contract, communication must be conducted in English.

7.3.21 General terms and conditions

The applicability of any of the Tenderer's general terms and conditions concerning delivery, payment and/or any other matters is explicitly excluded. The LOGIC General Conditions of Contract for Services (On- and Off-shore) Edition 3 – March 2019 Annex 6 – Section II a and b) apply to the Contract.

7.3.22 Contract conditions

The draft Contract, and the corresponding LOGIC General Conditions of Contract for Services (On- and Off-shore) are included in the annexes. The Tenderers have the opportunity to ask questions, make comments and propose textual amendments.

The Tendering Authority is free to accept or reject the proposed textual amendments. The Tendering Authority will indicate whether or not the proposals have been accepted or rejected in the Memorandum of Information. By submitting the Tender, the Tenderer declares his consent to the (possibly amended) Contract. Only the definitive Contract will apply during the execution of the assignment.

7.3.23 Explanation and verification of the Tender

The Tendering Authority can request that the Tenderer explains his Tender in greater detail and/or provide substantiating documents. The Tendering Authority is entitled – although not obliged – to check the accuracy of all data and statements submitted within the scope of the Tender.

7.3.24 Request for supplementary information concerning the Tender

The Tendering Authority can ask Tenderers to provide supplementary information and/or clarification of their Tender.

7.3.25 Announcement of the award of the Contract

All Tenderers will receive a message simultaneously that announces the award of the Contract and substantiates its decision. All Tenderers are entitled to request further information regarding this decision from the Tendering Authority.

Standstill period

All Tenderers and stakeholders who dispute the award of the Contract and/or the verbal/written substantiation thereof can apply for a preliminary injunction at the competent civil court in The Hague. This must be done no later than 20 calendar days subsequent to the sending of the digital notifications concerning the award of the Contract. Upon expiry of this period, no more applications for a preliminary injunction can be submitted. In the event a Tenderer applies for a preliminary injunction, we kindly request that you send a copy of the summons to the Tendering Authority.

On the grounds of Section 2.129 of the Public Procurement Act the award of the Contract does not yet mean the Tenderer's Tender has been accepted. For the 20 calendar days subsequent to the sending of the digital notification of the award of the Contract, the Tendering Authority is not permitted to definitively award the assignment by concluding the Contract.

If a preliminary injunction is applied for during these 20 calendar days, then a waiting period will be required pending a judgement in the preliminary injunction proceedings. The judgement will serve as the basis for further decision making by the Tendering Authority.

If preliminary injunction proceedings are brought against the award of the Contract, then the Tendering Authority will notify the Tenderer of this fact. The Tenderer must ensure that his Tender remains valid for at least four weeks subsequent to the judgement in the preliminary injunction proceedings.

Interest in relation to the judgement

Tenderers who have an interest in the judgement in these preliminary injunction proceedings can only engage in these proceedings by means of intervention or joinder. The Tenderer cannot initiate separate proceedings or other judicial proceedings.
