The undersigned:

1. **Invest International Public Programmes B.V.**, a private company with limited liability, incorporated under the laws of The Netherlands, with has its registered office in The Hague, The Netherlands and its offices at Bezuidenhoutseweg 12, 2594 AV, The Hague, The Netherlands, registered with the Dutch Chamber of Commerce under registration number 83526617, duly legally represented in this matter by Mr. H.J.M. Oorthuizen, CEO Invest International group and Mr. B. Schilperoort, director Public Sector, Invest International Public Programmes B.V. signs also, hereinafter the group is referred to as **“Contracting Authority”**;
and
2. **<Name Contractor>**, located at **<name of place>**, with Chamber of Commerce number: **<registration number>** represented by Mr/Mrs **<First name> <Surname>**, **<Function>**, hereinafter referred to as **“Contractor”**

collectively referred to as the Parties

CONSIDERING THAT:

1. The Contracting Authority has a need for a feasibility study concerning strengthening the capacity of 14 referral hospitals in Uganda;
2. A European public tender for the award for participation in this Agreement has taken place for this purpose;
3. The Contractor has made himself sufficiently aware of the Services/Assignment to be provided, is willing and able to perform the Services/Assignment referred to in this Agreement and has submitted a Proposal to this effect on **<...day/month/year...>**, which Proposal ended second in line;
4. The Contracting Authority has awarded the Agreement for ‘Strengthening the capacity of 14 referral hospitals in Uganda’ to **<name of awarded party>** until **<...day/month/year...>**. The start date is **<...day/month/year...>**;
5. This Waiting Room Agreement concerns a 'shadow agreement' and is only entered into after dissolution of the Agreement with the winner of this European tender with reference A01.001.2022;
6. Against this background, the parties enter into this Waiting Room Agreement with each other, subject to the following conditions and stipulations.

DECLARE THAT THEY HAVE AGREED AS FOLLOWS:

This Waiting Room Agreement is exclusively subject to the Arvodi 2018.

Artikel 1 Definitions

In this Waiting Room Agreement, the following definitions apply:

1. Agreement: the Agreement to be concluded with contract number **<contractnumber>**, including all appendices.
2. Contractor: the Contractor who has finished as number two in rank in the tender procedure on the basis of which the Waiting Room Agreement is concluded with him.
3. Waiting Room Agreement: this Agreement.

Section 2 Entering into force

1. The Contracting Authority has the right to terminate the Agreement with the winning tenderer prematurely as included in the concept Agreement of the European tender "strengthening the capacity of 14 referral hospitals in Uganda" with reference A01.001.2022.
2. The Contractor has the unilateral right to decide whether or not to use this Waiting Room Agreement. On termination of the Agreement, the Contracting Authority may also decide to re-tender. If the Contracting authority decides not to use this Waiting Room Agreement, it will not be obliged to pay any compensation for costs and/or damage to the Contractor.
3. The Contracting Authority will notify the Contractor in writing of its decision whether or not to use this Waiting Room Agreement. If the Contracting Authority decides not to make use of this Waiting Room Agreement, this Waiting Room Agreement will be terminated immediately and no rights can be derived from this Waiting Room Agreement.
4. The Contractor shall maintain its tender during the first contract year.
5. Contractor is willing to execute the Waiting Room Agreement.
6. If the Waiting Room Agreement is utilized, an Agreement will be prepared equal to the original Agreement for the remainder of the contract period. This Agreement shall contain the submitted rate (Appendix 4), of the Contractor signing the Waiting Room Agreement. The original Agreement concerns the Agreement as established in the European tender "strengthening the capacity of 14 referral hospitals in Uganda" with reference A01.001.2022.
