Concept Waitingroom Agreement (Appendix 16)

Vraag:

Chapter 4.5 of the Tender Guide states that the Contractor must be able to take over the performance of the Assignment in full within a period of nine (9) months of written notification from the Contracting Authority until the date of expiry of the Agreement. In Section 2 "Entering into force", under number 3 of the "Draft Waiting Room Agreement" (appendix 16), it states "The Contractor shall maintain its tender during the first contract year". These 2 paragraphs do not match. Could you please explain this?

Antwoord:

What Section 2 "Entering into force", under number 3 of the "Draft Waiting Room Agreement" (appendix 16), states, is correct. What is stated in chapter 4.5 of the Tender Guide should be 2 months instead of 9 months. So: "the Contractor must be able to take over the performance of the Assignment in full within a period of two (2) months of written notification from the Contracting Authority until the date of expiry of the Agreement."

Chapter 5.5 Award Criterion 'Price' of the Tender Guide states "The Contracting Authority applies a maximum price of € 400,000.00, inclusive of VAT. Does VAT which can be reverse charged also be in the maximum price included or is this kind of VAT excluded?"

Antwoord:

This VAT is excluded. Article 5.5 'Award Criterion 'Price' of the Tender Guide will be adjusted as follows: "The maximum price excludes Dutch VAT or reverse charge VAT if the Contractor is established in (the European part of) another EU Member State or VAT due under the law of Norway, Iceland, Liechtenstein.

If the Contractor is established outside (the European part of) the EU, or outside Norway, Iceland or Liechtenstein, the maximum price of the

Proposal shall include VAT established outside the EU or EEA (European Economic Area).

The maximum price further includes all taxes, levies or duties not specified herein, which have been or will be levied in or outside the Netherlands, by a country or part of a country (which has the power to levy taxes independently).

The maximum price is inclusive of any transaction and/or foreign exchange and/or other charges payable by the Contractor on account of exchange of charges incurred by the Contractor in other currencies to Euro or vice versa."

To article 3, 'Price and other financial provisions' of the concept agreement (appendix 8), the following text in a separate paragraph will be added: "The price includes all taxes, levies or duties not specified herein, which are or will be levied in or outside the Netherlands, by a country or part of a country (which has the power to levy taxes independently). The price includes any transaction and/or currency and/or other charges payable by the Contractor on account of exchange of charges incurred by the Contractor in other currencies to Euro or vice versa."
