Description: Gasunie has set up an LDAR programme for its assets, which aims to detect unintended methane emissions, repair them and thus reduce them. The contract with the current service provider is due to expire, and Gasunie wants the new contract to do justice to the new legislation that is currently being drawn up. Gasunie intends to enter into a new contract for all measurements of fugitive emissions and leakage losses (CH₄, CO₂ and H₂) through a Leak Detection (LDAR) programme. In addition, there are internal policy agreements that may be supplementary. The Gasunie network is also constantly evolving, so no rights can be derived from the scope described. Numbers of leakage sources, measurement frequencies, methods of reporting, etc. may change over the years. In addition to, +/- 12000 kilometres of pipeline, the natural gas network consists of the following assets: • +/- 16 large plants, such as compressor stations, nitrogen production facility, LNG plant; +/- 460.000 sources • +/- 80 smaller plants like metering and control stations, export stations, etc. +/- 350.000 sources • +/- 1.000 Gas receiving stations; +/- 480.000 sources • +/- 3.100 overhead and underground valve stations +/- 130.000 sources Together, these assets contain a total of about 1.4 million potential leakage sources.
