- The installation of the offshore pipeline section. Approximately 20 km. The primary pipe configuration is a 16 inch nominal diameter, MLPP anti corrosion & thermal insulation coating with a concrete weight coating on top of the MLPP.
- Backfilling of the dredged sections of pipeline
- Post-lay trenching and backfilling of the non-dredged sections of the pipeline
- The fabrication and installation of the subsea spool pieces & the related pipeline tie-in to the riser.
- The fabrication and installation of the riser and associated clamps
- Installation of a boat landing (optional scope)
- Pre-commissioning activities from onshore battery limit
