Tender Gas

Subject matter and objective of the tender

The Max Planck Institute for Psycholinguistics wants to award a new gas supply contract for the period **01.08.2024-31.07.2027**.

The Max Planck Institute for Psycholinguistics in Nijmegen is one of more than 80 research institutes of the Max Planck Society, and one of the few outside Germany. The institute is devoted exclusively to psycholinguistics - research into language processing in the brain. This includes how we produce and understand language, and how we acquire these skills in a first or second language.

General information on the call for tenders

As described above, the Max Planck Institute for Psycholinguistics (MPI) is a dependent institute that belongs to the Max Planck Society for the Advancement of Science. It is largely financed by public funds and must therefore follow German procurement principles. Therefore, this call for tenders is based on the German Regulation on the Award of Public Contracts (VgV) and the German Regulation on the Award of Subthreshold Contracts (UVgO).

In accordance with §8 UVgO, the MPI publicly publicized its intention to award this contract on TenderNed and is asking companies to submit quotations. The contract will be awarded to the company that submits the most economical quotation. In this case, only the price will be taken into account.

We expect the service to be carried out by the contractor itself.

Quotations can be submitted via TenderNed until 25.04.2024 at 12 noon CET.

Tenders submitted after this time will not be considered.

The order can only be placed with suitable contractual partners. Suitability will be checked by submitting the documents for the suitability check from the enclosures to this publication.
