1 GENERAL INFORMATION

1.1 Introduction

This document contains information on the market consultation for wellheads and x-mas trees for HyStock. The information gathered through this market consultation will be used by Gasunie for the preparation of a European tender for the wellheads and x-mas trees on behalf of N.V. Nederlandse Gasunie (hereafter: Gasunie).

With regard to the European tender to be started, no rights can be derived from the information provided in this document.

The purpose of this document is:

- to provide information about Gasunie,
- to provide the request to market parties about the materials required and
- to reflect the process of the market consultation.

1.2 Who is N.V. Nederlandse Gasunie?

Gasunie is an energy infrastructure company. In the Netherlands and Northern Germany, we manage the infrastructure for large-scale transport, storage and conversion of gas, currently still mostly natural gas. With the energy transition, this is increasingly shifting towards green gas and hydrogen. We are also working on the construction and management of heat and CO2 networks.

1.3 HyStock H2 storage project

Gasunie is working on the HyStock hydrogen storage project near Zuidwending in the Netherlands. Gasunie is planning to develop here the first large-scale hydrogen storage site in northwest Europe. The Zuidwending site is situated on top of a salt dome that is ideally suited to underground hydrogen storage. In this way energy can be stored. At the end of 2026, the first cavern and an above-ground installation will be put into operation. It is expected that four hydrogen caverns will be needed by 2030 to meet the demand. To this end, the current above-ground plant needs to be expanded. It is planned, that in the future the H2 caverns will connect to the H2 Back Bone project, which is still under development. With a connection to the national transport network for hydrogen (H2 Back Bone project), it will be possible for companies throughout Northwest Europe to supply and purchase hydrogen. In this way HyStock is facilitating the energy transition to a clean and sustainable society.

In addition to existing natural gas caverns owned by EnergyStock, 4 new caverns can be realised for hydrogen storage. The envisaged storage facility will be developed in steps, starting with a first cavern in 2028 and then expanding to at least four caverns from 2030. The storage facility will be accessible to the entire market on an open-access basis. Via a connection to Gasunie's national hydrogen infrastructure, which is currently under development, the stored hydrogen can be offered by producers and supplied to customers throughout the country and to the industrial clusters in Germany and Belgium from 2026 onwards.

1.4 Why is Gasunie conducting a market consultation?

To get a clear insight into the possibilities in the market, it was decided to carry out a market consultation. Gasunie invites suppliers to respond and greatly appreciates their contribution.

Gasunie hopes to gain more clarity on the following points:

- Are Gasunie's requirements relevant, realistic and achievable. In other words, can the market deliver wellheads and x-mas trees according to the scope Gasunie can currently provide.
- Gather information from the market about wellheads and x-mas trees suitable for hydrogen, natural gas, CO2 and nitrogen applications as described in paragraph "1.5 Scope of the contract";
- What solutions the market offers in relation to the questions and requirements of Gasunie;
- Obtaining a cost indication to be able to set the target value of a tender as accurately as possible;
- What does the market look like and what differentiates parties;
- The expected trends and developments in the market of wellheads and x-mas trees.

Gasunie wants to use the information obtained from the market to prepare a European tender for wellheads and x-mas trees.

Below in chapter "2 *Procedure*" you can read how to submit your response to Gasunie.

1.5 Scope of the contract

For the 4 new caverns for hydrogen storage as described in paragraph 1.3 Gasunie foresees the need for wellheads and x-mas trees.

There is also a possibility that Gasunie will need wellheads and x-mas trees suitable for other media such as nitrogen, CO2 and natural gas.

Gasunie is also looking at the possibilities for refurbished maintenance and would like to hear from market parties in this market consultation whether this is possible.

The scope of the wellhead and x-mas tree as currently foreseen by Gasunie is shown in:
