The present project aims to i. promote the knowledge management and exchange within and among the three partnerships on how local processing can contribute to a living income increase in the cocoa sector; ii. contribute to the global research agenda on understanding the direct and indirect effects of local processing on the cocoa-producing households living income and iii. foster cooperation and partnerships between Ivorian and Dutch knowledge institutes on living income in the cocoa sector.
