	<b>General</b>	
1	<p>In this Program of Requirements, the term "Contractor" refers to:</p> <ul style="list-style-type: none"> <li>• During the procurement procedure: the business that has submitted a tender;</li> <li>• After the award of the contract: the business to whom the contract has been awarded.</li> </ul>	
2	The Contractor unconditionally agrees to all terms, requirements, provisions, and regulations as set out in the Invitation to Tender, all accompanying annexes, and the Memorandum of Information.	
3	The Contractor's tender has a validity period of at least 60 days.	
	<b>Laws and Regulations</b>	
4	The Contractor declares that all products delivered/to be delivered by him comply at a minimum with all relevant laws and regulations in The Netherlands, including the European Directive on the safety of toys 2009/48/EC	
5	The Contractor shall, upon request by Naturalis, provide the technical documentation as referred to in Article 4.2 and Article 21 of the European Directive on the safety of toys 2009/48/EC within 5 working days..	
	<b>Sustainability</b>	
6	All plush toys to be supplied by the Contractor are made of at least 95% recycled polyester, wool, cotton, and/or granulate.	

7	If the filling consists (partly) of granulate, it must be free of solvents and not contain any plasticizers, BPA, and/or phthalates.	
8	If the Contractor wishes to offer plush toys made from materials other than those specified in requirements 6 and 7, prior approval must be obtained from Naturalis.  <b>NOTE: IF THE CONTRACTOR WISHES TO OFFER PLUSH TOYS IN ITS TENDER BID THAT DO NOT (FULLY) COMPLY WITH REQUIREMENT 6 AND/OR REQUIREMENT 7, THE CONTRACTOR MUST REQUEST PERMISSION FOR THIS. THIS CAN ONLY BE DONE THROUGH THE PROCEDURE DESCRIBED IN PARAGRAPH 5.5 OF THE INVITATION TO TENDER.</b>	
9	All packaging materials used by the Contractor are recyclable.	
	<b>Delivery times</b>	
10	All plush toys ordered by Naturalis will be delivered within 6 weeks	
	<b>Invoicing and payment</b>	
11	The Contractor will invoice the ordered plush toys after delivery.	
12	The Contractor agrees to a payment term of 30 days after receipt of the invoice.	
	<b>Warranty</b>	
13	If it is found that the products delivered by the Contractor do not meet the specified requirements, the quality offered in the tender, and/or relevant laws and regulations, Naturalis is entitled to return these products to the Contractor. The Contractor shall refund the purchase price paid by Naturalis as well as the transport costs within 14 days.
