This amendment (“Amendment”) is entered into between the parties identified on the attached program signature form. It amends the Enrollment or Agreement identified above. All terms used but not defined in this Amendment will have the same meanings provided in that Enrollment or Agreement.

Enterprise Agreement

Amendment ID CTM

Notwithstanding anything to the contrary or in addition to any terms in the Microsoft Business and Services Agreement (“**Master Agreement**”), Enterprise Agreement and Enrollment, until November 30, 2027, the Enterprise Agreement is amended as follows:

Preamble:

This Amendment supplements the commercial framework between Vereniging van Nederlandse Gemeenten (“VNG”) and Microsoft expiring by the end of November 2022. The conditions in this Amendment will be valid for Enrollments with a start date on or before December 1, 2026.

For avoidance of doubt, this Amendment does not modify the conditions of the expiring framework.

Commercial Framework 2022 - Modern Workplace and Power Apps

Eligibility

This commercial framework will only be available to Affiliates of VNG under the Enterprise Agreement with reference 52E60908. For avoidance of doubt, to be eligible these Affiliates must satisfy the criteria in the Microsoft Government Eligibility Definition (EMEA).

Term

The term of each Enrollment under this commercial framework will be 60, 48, 36, 24, or 12 months, with an expiration date not earlier than November 30, 2026, and not later than December 31, 2027.

Commercial conditions

Enrolled Affiliate's prices for each Product or Online Service will be established by its Reseller. Under this commercial framework, Microsoft will grant the Enrolled Affiliate's chosen Reseller discounts on the Estimated Retail Price for the specific SKUs that are listed in “Table 1 - Discounted Pricing Offer - Maximum Resale Price (MRP) in Euro” below. The prices in this table represent the Maximum Resale Price (MRP), which is calculated by deducting the applicable discount from the Estimated Retail Price for each specific SKU. All prices for these SKUs are based on the November 2022 price list, Government Level D, in Euro. For all other products, the then-current price list will apply.

The Maximum Resale Prices indicated below apply during the respective year indicated as follows:

- MRP Y1 applies during the year of the Enrollment for which the start date or anniversary date falls between December 1, 2022, and November 30, 2023.
- MRP Y2 applies during the year of the Enrollment for which the start date or anniversary date falls between December 1, 2023, and November 30, 2024.
- MRP Y3 applies during the year of the Enrollment for which the start date or anniversary date falls between December 1, 2024, and November 30, 2025.
- MRP Y4 applies during the year of the Enrollment for which the start date or anniversary date falls between December 1, 2025, and November 30, 2026.
- MRP Y5 applies during the year of the Enrollment for which the start date or anniversary date falls between December 1, 2026, and November 30, 2027.

** The values in the table are minimum values: The actual MRP for these SKUs will be determined by taking the highest of two prices as follows: i) the value in the table above and ii) the difference between the framework price for Microsoft 365 E5 (determined from this table) and Enrolled Affiliate's price for Microsoft 365 E3.

These commercial conditions apply only for on-time renewals. If a renewal is late, a 3% uplift may be applied to all Maximum Resale Prices at the discretion of Microsoft.

If Enrolled Affiliate places an order for Online Services using these commercial conditions, then the pricing in "Table 1 - Discounted Pricing Offer - Maximum Resale Price (MRP) in Euro" will apply for those Online Services for the duration of the Enrollment and any extension of the Enrollment. For avoidance of doubt, this means that for those Online Services, the pricing from Table 1 will prevail over the pricing from the expiring framework.

Minimum order requirements

For Affiliates that are listed in the category "Gemeenten" in the official registry of Dutch Government Organizations (available at <https://organisaties.overheid.nl>), the Minimum order requirements section of the related Enrollment is amended as follows:

Notwithstanding anything to the contrary in the Agreement, an Eligible Entity's Enterprise must have a minimum of 100 Qualified Users or Qualified Devices, and its initial order must include at least 100 Licenses in a single Product pool for Enterprise Products or Enterprise Online Services. If no Enterprise Product is ordered, an Eligible Entity need only maintain at least 100 Subscription Licenses for Enterprise Online Services.

Should an Affiliate that meets the requirements above have fewer than 100 employees, then Microsoft will work in good faith with that Affiliate to adapt this Minimum Order Requirement.

Except for changes made by this Amendment, the Enrollment or Agreement identified above remains unchanged and in full force and effect. If there is any conflict between any provision in this Amendment and any provision in the Enrollment or Agreement identified above, this Amendment shall control.

This Amendment must be attached to a signature form to be valid.
