1. GENERAL INFORMATION ABOUT THE PROCEDURE AND CONTRACT

1.1 Procedure

This document contains the information required to participate in the public tender for Peak delivery 2025-2026 for the benefit of Gasunie Transport Services B.V. (hereinafter: GTS).

The purpose of this descriptive document is to provide information on the requirements to be met by the participating parties, the procedure, the award criterion and the assessment procedure.

This tender is subject to the Dutch Public Procurement Act 2012 (Aanbestedingswet 2012); please note that Gasunie makes use of article 3.30 of the Aanbestedingswet 2012 for this specific contract.

GTS intends to award a contract to the Most Economically Advantageous Tender (MEAT) whereby the award criterion Lowest Price will be applied. Rationale for this criterion is that the following hard demands must be strictly met:

- Quality of the product, either G-Gas or H-Gas is very strict: there is no qualitative distinction between the various tranches.
- The peak gas must be physically delivered on TTF from a predefined physical gas storage installation connected to the Dutch GTS network, according to Appendix 1 of the TSC 2026.

1.2 Gasunie/Gasunie Transport Services

Gasunie is an energy infrastructure company. In the Netherlands and the northern part of Germany, we operate infrastructure for the large-scale transport, storage and conversion of gas. At the moment, this is mainly natural gas, but the energy transition is increasingly bringing about a shift towards green gas and hydrogen. We also work on the construction and operation of heat and CO₂ grids.

Our task is to ensure safe, reliable, affordable and sustainable energy infrastructure services, so that everyone has access to energy, always. Safety, reliability, sustainability and cost-effectiveness are central in everything we do.

With 17,000 kilometres of pipelines in the Netherlands and northern Germany, our network is one of the largest high-pressure pipeline networks in Europe. We transport natural gas and green gas through subsidiaries Gasunie Transport Services (GTS) in the Netherlands and Gasunie Deutschland in Germany. We also have other gas infrastructure services, including gas storage and LNG.

1.3 Subject of the tender

1.3.1 Introduction

Every year Gasunie Transport Services B.V. (GTS) organizes a tender to contract the required services for peak supply in order to fulfill its legal task.

- In order to fulfil its peak delivery task, GTS uses the Peakshaver installation at the Maasvlakte for part of the required volume and capacity needed for the Peak Supply 2025-2026,
- GTS is aiming to contract the remaining peak volume and capacity via this peak tender,
- GTS held talks with several potential service providers and discussed parameters for a peak service in order to have a successful tender,
- GTS bundled the feedback and included the feedback in the annex 4 - term sheet

1.3.2 Internal client: Department AO (Development and Planning department)

The AO department manages and plans the flow of gas within all GTS' assets. It includes [peak supply](#). Peak supply is described [in the Dutch Gas Act](#).

1.4 Scope of the contract

GTS will tender eighteen (18) tranches in total. Tenderer may offer for all tranches. The offer is to be made using Annex 5: the spreadsheet. In this spreadsheet Tenderer is also requested to specify, per tranche the physical gas storage installation (according to Appendix 1 of the TSC 2026) that will be used to deliver the peakgas at TTF. Upon activation of the peak delivery service, the Tenderer is required to deliver the gas from the specified source as indicated in Annex 5.

GTS is looking to contract Peak Services based on delivery of gas when called upon: see term sheet, and contract, for details.

A tenderer can be awarded none or from one (1) up to eighteen (18) tranches.

GTS is not obliged to award (a) tranche(s)..

Enclosed with the tender is annex 3: a template-contract. Please review the contract for all relevant details. With the submittal of a tender the tenderer declares to unconditionally agree with the content of the tender documents including the contract. In case a tenderer gets a contract awarded the/its offer will be included in/become part of the contract.

1.5 Intended result of the tender procedure

GTS intends to conclude contracts with one or more tenderers to ensure that all 18 tranches are covered. Such a contract has a term of three months with no option to extend it. The effective/commencement date is December 01, 2025.

1.6 Tranches

If Tenderer wants to submit an offer Tenderer must use Annex 5, the spreadsheet, for one or more tranches for Gas. 18 tranches are awarded in total, without a maximum per Tenderer.

Variants and alternative tenders

Submitting variants and/or alternative tenders is not permitted. Any variants/alternatives put forward will not be assessed.

2 TENDER PROCEDURE

2.1 Planning

Below is the planning for this tender. No rights may be derived from the schedule below. Dates shown in bold are final deadlines, unless otherwise notified by GTS. GTS reserves the right to amend the planning in the interim. The planning as stated in the latest note of information takes precedence.

2.2 Digital tender via TenderNed

This tender is carried out entirely electronically via <https://www.tenderned.nl>. This means that, among other things:

- All tender documents are made available free of charge and digitally on TenderNed;
- Tenderers' questions are submitted via TenderNed;
- Tenders can only be submitted digitally; and
- In principle, all further correspondence also takes place via TenderNed, unless there are questions about TenderNed (-procedure) itself, then you may contact Gasunie procurement directly.

Obtaining information about this tender from GTS other than as described above is not permitted. Communication about this tender, other than with the contact person mentioned above on the title page, can lead to exclusion from participation in this tender.

To make best use of TenderNed, it is also important for tenderers that their organisation is registered correctly and, among other things, the right people are given the proper authorisations for this tender procedure. Make sure this authorisation is also in place for holiday periods or other times when substitutions may be needed.

2.3 Language

The tender procedure is conducted in English. Unless otherwise stated or unless otherwise stated in writing by GTS in the subsequent tender procedure, all documents submitted by the tenderer must be in either Dutch or English. The same applies to the performance of the agreement throughout the contract period.

2.4 Tender costs

Tenderers will not receive any compensation for costs, damages or lost profits relating to the submission of a tender. If GTS withdraws the tender, it will consider whether a reimbursement of costs is deemed appropriate. It does not follow that there is an obligation to pay out such a reimbursement that takes into account all costs incurred.

2.5 Site visit ('indication')

2.6 Information and note of information

Questions may be submitted in writing about the tender procedure, the tender documents or their contents and/or the contract documents or their contents. Please use the Q&A TenderNed tool or alternatively the model provided in Annex 6 when submitting questions.

The deadline for submitting questions is indicated in the schedule in section 2.1

Please submit your questions as soon as you have them, even if you have more questions to come. It is the aim of GTS to answer them as fast as possible, so you may receive multiple notes of information.

The answers to the questions submitted will be formulated as an anonymised note of information. The note of information will be published via TenderNed by no later than the date specified in section 2.1. Tenderers are deemed to have taken notice of the contents of the note of information. The latest note of information takes precedence over the previous notes of information – if any, the descriptive document and its related annexes.

2.7 Submission

Your offer (tender), the filled in spreadsheet, must be submitted via TenderNed before the date specified in the planning. If in a note of information, the planning was adapted, it supersedes the planning in this document. Tenderer may, during the entire period until the deadline, edit, revise and withdraw its tender. **Any information submitted by the tenderer only becomes visible to GTS after the expiry of the deadline.**

All tender documents to be submitted with the tender that specifically require a signature must be lawfully signed. Adding additional information not explicitly requested by GTS is not permitted. Such additional information will not be included in the assessment. The tenderer is responsible for the timely submission of its tender. Tenderers are therefore strongly advised to upload and release the relevant data well before expiry of the above mentioned deadline. TenderNed will automatically close exactly at the time specified. It is not possible to submit a tender after the deadline.

2.8 Content of the submission

By submitting a tender, the tenderer declares that it is fully aware of the contents of this tender document, all annexes, and the anonymised note of information to be received, and any other accompanying documents, and also that it agrees with all the provisions and requirements of these documents.

Also, by submitting the tender, the tenderer declares that it has answered all questions and attachments fully and truthfully, and that the information provided corresponds with reality, and is correct and complete. If, after submission of the tender, it appears that this is not the case, this may result in exclusion from further participation in the tender procedure.

Documents to be submitted with the tender

Tenders must be prepared and submitted in full compliance with the provisions. If a tender has not been prepared and/or submitted in full compliance with the provisions, GTS may decide to exclude

this tender from further participation in this procedure. The tender in question will then no longer be eligible for award.

The document to be submitted is Annex 5: the spreadsheet *OfferGTSPeakDelivery2025-2026.xlsx*.

2.9 Decision not to participate

If a tenderer decides not to submit a tender, the tenderer is kindly requested to report this as soon as possible.

2.10 Ambiguities, contradictions and forfeiture of rights

The tender documents have been compiled with care. If the tenderer nevertheless discovers errors/contradictions/faults/deficiencies/omissions or ambiguities in the tender documents, the tenderer must take a proactive approach by informing GTS itself as soon as possible, no later than at the time of the information round (note of information) by asking questions or submitting comments/objections.

If the tenderer fails to comply with this obligation, the tenderer forfeits its rights to raise any errors/contradictions/faults/deficiencies/omissions or ambiguities afterwards in court.

If the tenderer submits an objection during the information round(s) and Gasunie, to the opinion of the tenderer, does not or not adequately resolve that objection, the tenderer must take a proactive approach. The minimum requirement is that the tenderer - in the event that it cannot (yet) reconcile itself to the settlement of the objection - explicitly states, in writing and stating reasons, to the Gasunie that it maintains its objection. This statement needs to be submitted to Gasunie as soon as possible but no later than two days prior to the deadline for submission of the tender.

If the tenderer does not comply with the possibilities offered in this section, this will be at the risk of the tenderer and both Gasunie and the other tenderers will be justified in assuming that the tenderer has no questions and/or objections (left) regarding the procedure and/or contract. Raising objections and/or ambiguities only after the date of submission of the tender will lead to inadmissibility (on the grounds of legal effect) as far as those objections and/or ambiguities are concerned.

2.11 Complaints about the tender process

Gasunie has its own complaints procedure with respect to tenders, see Annex 2. You can submit complaints in writing to Gasunie's complaints desk using the following email address: klachtenmeldpunt.aanbestedingen@gasunie.nl. Please state clearly in the email which tender the complaint relates to, what the complaint is and how you think the problem can be remedied. The complaints procedure for tenders is published and can be consulted at www.gasunie.nl/leveranciers

Submission of a complaint does not automatically suspend the tendering procedure.

3 REQUIREMENT

The assessment of the tenders received on time will be subject to the provision mentioned in this chapter. Failure by the tenderer to comply with this requirement may result in exclusion from participation in this tender procedure.

Requirement to be met is that a tenderer needs to be qualified as a GTS shipper according to the requirements of GTS to become a qualified GTS shipper.

All the qualifications GTS needs for peak delivery are mentioned when supplier became a GTS shipper. Gasunie/GTS will check if the tenderer who submitted an offer is a qualified GTS shipper. If a tenderer is not a qualified GTS shipper the offer made will be regarded as null and void and disregarded.

4 AWARD CRITERION

The award criterion is the MEAT- lowest price per tranche, without a maximum tranches per Tenderer.

5 ASSESSMENT AND AWARD PROCEDURE

5.1 Assessment of the submissions

GTS will go through the following steps to assess the tender:

1. Assessment of whether the tender has been submitted on time. If the tender is not submitted on time, the tender may be considered invalid;
2. Assessment of whether the tender has been submitted in full (complete). If the tender has not been submitted in full, the tender may be considered invalid;
3. Assessment of whether the tender is in accordance with the set requirements. Please note the requirement regarding being a GTS shipper. If the tender is not in accordance with the set requirements or is conditional, the tender is considered invalid;
4. Evaluation of the valid tenders on the basis of the MEAT (Most Economically Advantageous Tender) - lowest price per tranche, without a maximum tranches per Tenderer; and
5. Publication of the award decision (see planning);

Ad. 1. Please submit well on time as the deadline is precise to the second. At GTS the submission by tenderer can only be seen when the deadline has passed, not before.

Ad. 4. GTS will put all offers in one list ordered by price (ranked from lowest to highest).

GTS will award the eighteen (18) lowest priced tranches.

In case GTS does not receive valid tenders for all 18 tranches Gasunie reserves the right and shall be entitled to pursue the intended result by other means in order for Gasunie to be able to meet its legal obligations.

The offer by tenderer needs to have a validity period of 30 days from the last day on which the tender needed to be submitted.

5.2 Notification of immediate exclusion

If the assessment referred to in section 5.1 gives rise to the immediate exclusion of one or more tenderers because their tender is incomplete and cannot be remedied, GTS will notify the tenderer in question in writing as soon as possible.

If the tenderers that were immediately excluded do not agree with the exclusion, and wish to commence summary proceedings, they must do so within the time specified and in the manner as indicated in the notification of immediate exclusion.
