1. his company or a director thereof in the four years prior to the submission of the request for registration or quotation or the supply or service now requested has not been convicted by an irrevocable court decision for:
 - a. participation in a criminal organization;
 - b. bribery;
 - c. fraud;
 - d. money laundering.
2. his company is not in a state of bankruptcy or liquidation, its activities have not been discontinued, it is not subject to a moratorium or a (bankruptcy) composition, and its company is not in another comparable situation as a result of a similar procedure that occurs in the applicable laws or regulations.

3. his company has complied with the obligations on the basis of statutory provisions applicable to him with regard to payment of social security contributions or taxes.
4. his company, when providing information required of him by the Rijksdienst Caribisch Nederland in the context of an assignment, has not been seriously guilty of false statements or his company has not provided this information or has not provided this information in full.
5. he declares in good faith that there is no Russian involvement in the implementation of agreements to be concluded that exceed the thresholds of Article 5k of EU Regulation (EU) 833/2014 of 31 July 2014 on the relevant restrictive measures following the Russia's actions destabilizing the situation in Ukraine, as amended by Regulation 2022/578 of April 8, 2022.
he declares in particular that:
 - a. the contractor he represents (and the companies that are part of the consortium) are not (legal) persons with Russian nationality and these (legal) persons (natural persons, companies, entities or bodies) are not established in Russia;
 - b. the contractor he represents (and the companies that are part of the consortium) are not legal entities (established in Russia or another country) that are more than 50% owned by a Russian party as referred to under a) above;
 - c. neither he nor the company he represents is a (legal) person (established in Russia or another country) acting in the interest of or at the direction of a Russian party, as referred to under a) and b);
 - d. no subcontractors, suppliers or companies participate whose capacity is called upon by the contractor he represents and who have a share of more than 10% of the contract value, whereby a situation as under a) to c) occurs.For each Tenderer, he/she declares by submitting a tender that he/she will not act in conflict with what is described above. The contracting authority/client is free to request additional information, explanations or documents in order to determine the correctness of this statement.
6. he has signed this Self-Declaration unconditionally and without any reservation; he is aware that the provision of incorrect or incomplete information can be regarded by the Rijksdienst Caribisch Nederland as a false statement within the meaning of point 4 of this Personal Statement and that this may lead to an unconditional exclusion from obtaining this assignment and / or follow-up assignments.
