The inspectors shall, on behalf of Gasunie, perform inspection of pressurized gas transport related equipment and pressure containing components, mainly carbon steel. Inspections are done all over Europe, with emphasis on the Netherlands and Germany's Ruhr district. Further inspections are mainly needed in northern Italy, Denmark and the United Kingdom.
